MANAGER'S/TREASURER'S REPORT: Manager Kunkel reported on November savings realized by using CalCARD, Rincon submitted their 43 page report to Permit Sonoma and requested information from them on which, or all, of three (3) possible permits might be needed. Depending upon with reports Permit Sonoma needs, the cost estimate could range between \$57,000.00 and \$70,000.00. Rincon is waiting for a response. Our contact in the supervisor's office, Jen Mendoza, has been unsuccessful in trying to secure a promised list of vendors they have worked with for required permits. There were 1,605 visits to our web page in November, six (6) general communications and five (5) requests for information. As of the Trustee Meeting of December 15, 2001 there were no changes to our COVID-19 procedures. Reallocations for November have been completed, submitted and accepted.
