GROUNDS MAINTENANCE SUPERVISOR'S REPORT: Grounds Maintenance Supervisor Kramarsic reported that general maintenance remains on track; biggest tasks are keeping lawns mowed and grounds blown of leaves and debris; and no new water cutbacks have been announced by the Town of Windsor. We have had 6 services since the last board meeting. Chris from North Bay Tree and Weed did two walk throughs and Richard from Town of Windsor discussed the water situation in general and provide updates.

MANAGER'S/TREASURER'S REPORT: Manager Kunkel reported on September savings realized by using CalCARD, the next phase of Rincon supervised biological report of our Annex, limited progress with the supervisor's office; specifically that Fee Waivers cannot be granted to any entity that receives tax money even if requested by our county supervisor. Our contact is attempting to have the amount of money that would have been granted by a Fee Waiver provided to us as a budget item of the District budget.

September web page visits totaled 1,616. There were seven (7) general communications, eight (8) requests for information and four (4) community education calls. September Reallocations and 1/4ly taxes were completed and submitted ahead of deadline.
