We believe we've been transferred to another pond but the problems persist. We will try to help the lawns by applying soil conditioner, fungicide, and hydretain; applied by North Bay Tree and Weed. We are working on a plan. There have been three (3) services since the last meeting. Approximately 80 feet of fence was destroyed by a DUI driver on the eastern side of the Oak Lawn. We have been in touch with Windsor PD and we are also waiting on quotes from fencing companies to effect repairs.

MANAGER'S/TREASURER'S REPORT: Manager Kunkel reported on July savings realized by using CalCARD. Community education was discussed. Shiloh Annex progress was discussed; our Annex application was accepted and the invoice and payment in the form of a check for \$8,222.00 has been sent. There were 1,387 visits to our webpage in July. Reallocations for July we completed, submitted and accepted. An insurance true up was completed for Golden State Risk Management. We hope to receive a refund check as we did last year.
