GROUNDS MAINTENANCE SUPERVISOR'S REPORT: Grounds Maintenance Supervisor Kramarsic reported that maintenance on grounds is going well. The Town of Windsor turned on reclaimed water on April 1, 2021 and the supervisor retrained Paul Klein and Jeff Kramarsic for SDC property. Reclaimed water was used to pressurize our irrigation systems on April 6, 2021. The Town of Windsor mowed the Annex for us which we very much appreciate.

MANAGER'S/TREASURER'S REPORT: Manager Kunkel reported on March savings realized by using CalCARD, and that the late charges for the 2016/2017 were refunded due to negotiating a longer grace period and backdating it to 2016/2017. Drilling of the three (3) wells on our annex for the ground water assessment has been completed. Two (2) were dry and one (1) showed water at 18 feet. Our web page had 528 hits and multiple families were advised on the burial process in the name of community education. We discussed continued COVID-19 protection efforts for staff and families, burials, deposits and expenditures. Manager Kunkel also reported that the FY 2019/2020 audit is complete, and we were in the process of developing the FY 2021/2022 Preliminary Budget. The annual Financial Transaction Report and Special Districts Government Compensation Report have been completed and submitted. Q1 quarterlies were completed and submitted.
