We continue to stay in communication with the Town of Windsor, Polyguard, Windsor Golf Course, North Bay Tree and Weed and with other cemeteries.

MANAGER'S/TREASURER'S REPORT: MANAGER'S/TREASURER'S REPORT: Manager Kunkel reported on September savings realized by using CalCARD. Expenditures and deposits were discussed as was Shiloh Annex progress. Steven Sharp reached Permit Sonoma and has a meeting scheduled with

LACO and Rincon. The focus is to be setback of roadways and the rare Tar Flower. There were 10,689 visits to our web page in September with 11 general communications and nine (9) requests for information. We advised eight (8) families on the burial process. Reallocations for September were submitted and accepted. We updated the GSRMA Annual Financials for FY 2025/2026 that predicts our next FY Financials using our current numbers. Once the final numbers are reported at the end of the next FY, a True-Up process will rectify outstanding amounts.
