GROUND MAINTENANCE SUPERVISOR'S REPORT: Supervisor Kramarsic reported that the Town of Windsor has been having reclaimed water issues again; the water is dirty and we are experiencing low pressure. Supervisor Kramarsic is working with the Town on resolutions. Since our June board meeting, there have been three (3) services. Restitution payments for the damaged fence line on the east end of the Oak Lawn have been coming in. So far we have received three (3) checks for \$500.00 each. We have been working with Chris at Northbay Tree and Weed on weed control and soil conditioner for the lawns.

MANAGER'S/TREASURER'S REPORT: Manager Kunkel reported on June savings realized by using CalCARD. Expenditures, and deposits were discussed as was Shiloh Annex progress. Rincon Consultants has completed their wetland and plant survey. LACO Associates completed their topographical surveys


and are developing a recommended layout. June reallocations were completed and submitted as were quarterly taxes.
